REGOLAMENTO



1. ORGANISATION

MARATEALE FILM FESTIVAL, previously called Giornate del Cinema Lucano is organised by the Association Cinema Mediterraneo (<https://www.marateale.com>) and will take place in the Amphitheatre of the prestigious Santavenere Hotel and in other places in Maratea.

2. MARATEALE IN GREEN

The Marateale in Green is a new sidebar of the festival which promotes environmental sustainability in compliance with the goals set in the 2030 Agenda for Sustainable Development of the United Nations.

Ten films (animation, documentaries, feature films) dealing with environmental aspects will be selected to participate in the Competition MARATEALE IN GREEN.

All films submitted have to be completed before 1st January, 2019 and have a running time of 60 minutes or more.

3. PLACE – DATES

The Marateale Film Festival will take place in Maratea (Pz) from the 27th-31st of July 2021

4. JURY

The Festival management will nominate an International Jury composed of key players in the Film industry and the art world.

5. LEGITIMATE REPRESENTATIVE

The person who registers a film takes on the responsibility of being the legitimate representative of the rightholders of the proposed work. By submitting the filled in registration form, he/she exonerates the Association Cinema Mediterraneo of verifying the legitimacy of the latter to register the film, which shall be considered as confirmed, thus exempting the Association of any related liability.

6. REGISTRATION

Only national and international films, completed between 1 January 2019 and 30 May 2021, dealing with environmental themes, which have not yet been released in Italy are eligible for the Marateale in Green competition.

To submit a film to the Marateale in Green Competition it is necessary to fill in the application form to be downloaded on the official website <https://www.marateale.com>, under the heading application form and sent back via email to green@marateale.com. The film should be sent by vimeo link or through any other digital platform. It is important that the password is valid until the 31/7/2021.

Deadline for applications is 30/6/2021

Alternatively, it is possible to send a DVD, Blue ray or DCP to the address hereafter by 30/6/2021:

The submitted films do not need to be subtitled if the original version is in Italian; subtitled in English or Italian if the original version is in any other language.

7. FILM SELECTION

The official film selection of the films will be announced by 1/7/2021. Thereafter, sales and/or producers need to send following materials by 8/7/2021: posters, brochure, press kit if available, synopsis, DCP.

8. OSPITALITY

The organisation offers hospitality to a maximum of two representatives of the films participating in the MARATEALE IN GREEN competition. Film directors and leading actors will be privileged.

9. AWARDS

The MARATEALE IN GREEN will bestow two awards: Champion of Sea and Earth (for the commitment in favour of the environment and sustainability) and Mother Earth (for the film with the strongest social impact in favour of the protection of the planet). Moreover, The Music of Cinema Award will be bestowed for the best soundtrack..

10. GENERAL RULES

Submitting a film entails the full and unconditional acceptance of the present regulations.

The acceptance to participate in the competition and sending the materials implicitly gives the festival's organisation team the right to use short sequences of a maximum of 20 seconds on the festival's website or on any other promotional platforms, without claiming any kind of compensation. The material sent to the festival's organisation such as photographs, portraits of the directors, biographies and filmographies, synopsis, public declarations of the talents involved, posters etc. linked to the film, imply the non-exclusive authorisation to use the latter for the festival's catalogue, its website, or on any other promotional support.

The jury's decision regarding the awards is final.

Films and videos are covered by an "all damages" insurance policy (including loss and theft) underwritten by the Festival while in their keeping. In case of misplacement or damage, the Festival Organisers will be responsible for the cost of a new copy according to current Italian rates. Should any dispute arise regarding the interpretation of any article of these regulations, the original Italian version is binding.

The managing team of the MARATEALE IN GREEN reserves the right to settle any cases not covered by the present regulations and to make exceptions to the rules.

Any dispute will be governed by Italian law and shall be subject exclusively to the jurisdiction of the Italian court of Potenza.
